The First Meeting of the Research Committee (Academic Year – 2018-19))

The first meeting of the Research Committee of the academic year 2018-19 was held at the conference hall of the University on 07.08.2018. All the members were informed about the numbers of the students who have been conferred on the degrees of M.Phil. (Tatvacharya) and Ph.D. (Vidyavaridhi) during the time period from the time of the foundation of the University to the present day. All the members discussed about the future plan and put forward the suggestions.

- 1) The members have taken into consideration the tasks accomplished as mentioned in sr. no. 1.2.3, and 7.
- 2) The Committee recommends to approve the application of the research scholar Parmar Mayaben Ramanbhai and her guide, dated 15.06.2018 for the partial change in the title of her Ph.D. thesis from "मेधाव्रताचार्यरचित-दयानन्ददिग्विजयमहाकाव्यस्य साहित्यिकमध्ययनम्" to "'दयानन्ददिग्विजयम' महाकाव्यस्य परिप्रेक्ष्ये महर्षिदयानन्दः एकः समाजसुधारकः".
