Firstly, the Chairperson informed the IQAC that the University is preparing the Annual Quality Assurance Report (AQAR) of the year 2022-21 for its submission to NAAC, Bangalore. Secondly, he informed the IQAC that the University has successfully participated in Gujarat State Institutional Rating Framework (GSIRF) of the year 2021-2022 by submitting data to the Knowledge Consortium of Gujarat (KCG), Ahmedabad on 28.06.2022. All the members solemnly approved the works done and appreciated the University for the same.
2. **Item No. 1:** Solemnly approved the Terms & Conditions viz. Parameters to evaluate and short-list the Universities for admission of foreign students of ICCR, Ministry of External Affairs, Government of India.
3. **Item No. 2** Solemnly recommended providing Transit Accommodation facilities on chargeable basis to Foreign/NRI candidates in the University campus.
4. **Item No. 3:** Solemnly recommended to put up file for the same and to resolve it, as it is an administrative matter.
5. **Suggestion by Dr. Smita Chhag:** She suggested sending the research scholars (Ph.D.) to different schools and colleges for the orientation of all the students by



imparting the importance of the Sanskrit language and literature. All the members solemnly approved the suggestion and recommended the *Prachar-Prasar Samiti* of the University to implement it.

6. **Suggestion by Dr. Jayesh Vaghasia:** He suggested increasing the Co-curricular/ Extra-curricular activities in the University. All the members solemnly approved the suggestion and recommended the Head, P.G. Section of the University to implement it.
7. **Suggestion by Dr. Janakisharan Acharya:** He suggested enriching the Manuscript Resource Centre (MRC) of the University by sending a proposal to National Mission for Manuscripts (NAMAMI) for staff and resources. All the members solemnly approved the suggestion and recommended the Library Section of the University to implement it.
8. **Suggestion by Dr. Dasharath Jadav:** He suggested organising a *Sambhashan Shibir* for the professionals like doctors, advocates, bureaucrats etc. of the Veraval city with their families. All the members solemnly approved the suggestion and recommended the *Prachar-Prasar Samiti* of the University to implement it.
9. **Suggestions by the Chairperson:** Firstly, he suggested organising a Workshop on Manuscriptology and Palaeography in collaboration with National Mission for Manuscripts (NAMAMI) by sending a proposal to it. All the members approved the suggestion and recommended the Research Section of the University to implement it.

Secondly, he suggested implementing NEP-2020 in the University as per the directions of Government of Gujarat and Government of India. All the members solemnly approved the suggestion and recommended the NEP-2020 Implementation Committee of the University to implement it.

Thirdly, he informed the IQAC that the University will participate in the National Institutional Ranking Framework (NTRF) in future course of time. All the members approved the works to be done.
