3.	A distinguished academician, with a minimum of 10 years of experience as Professor in a
	University system or in an equivalent position in a reputed research or academic administrative
	organization with proof of having demonstrated academic leadership.
4.	A person possessing highest level of competence, integrity, morals and institutional commitment.
5.	Able to provide leadership by his/her own example.
6.	Able to provide vision and have ability to translate the same into reality in the interest of students
	and society.
